

REGULAR CITY COUNCIL BUSINESS MEETING TUESDAY, OCTOBER 10, 2017

MEETING MINUTES

1. CALL TO ORDER/ROLL CALL/PLEDGE OF ALLEGIANCE

Mayor Tollefson called the meeting to order at 7:01 pm in Council Chambers.

Mayor Tollefson, Deputy Mayor Blossom and Councilmembers Peltier, Medina, Roth, Scott and Townsend were present.
