1. Call to order

- 2. Open Public Meetings Act Training

Also, Committee members are interested in having an update of existing commitments that the City has made on climate change. This information will help us identify where the Advisory Committee recommendations would be most useful.
- At the October meeting, the Advisory Committee will develop a list of questions for City staff and/or department heads based on their responses to the table in order to better understand implementation plans, actions, and challenges, following the integration of climate change considerations into Comprehensive Plan goals and policies.
- The co-chairs will ask the Council Liaison about extending an invitation to these City managers to attend the November Advisory Committee meeting for discussion.

9. Greenhouse gas inventory

 A subcommittee was established to continue the discussion about greenhouse gas inventory options and develop a summary table. The subcommittee, comprised of David McCaughey, Derik Broekhoff, and Michael Cox, will report out to the broader Committee at the next meeting.
