

PETITION
To The City Of Bainbridge Island

We, the undersigned, are residents of Bainbridge Island living on or near Wardwell Road. We have been notified that the City's "Wardwell Reconstruction Project," currently in progress, will include "roadway surface reconstruction and storm drainage improvements." We respectfully ask that the roadway surface reconstruction include installation of "speed bumps" to help control a dangerous situation.

Humps HeB

We submit this Petition based on the following observations:

1. Wardwell Road provides the sole route for ingress and egress to our neighborhood and, as such, is heavily used by vehicles and pedestrians;
2. Drivers often exceed the posted speed limit (25 mph) on Wardwell Road, sometimes to a very significant extent (estimated 40-50 mph or more);
3. This frequent speeding poses a major risk to children, pets and wildlife, as well as to other drivers and property;
4. Bainbridge Police rarely (if ever) patrol this neighborhood to monitor and discourage traffic violations;
5. To some extent, the existing rough surface on Wardwell Road has helped to reduce speeding (over the portion that was recently repaved, speeding has become noticeably more frequent);
6. Once the lower portion of Wardwell Road is re-surfaced, it is predictable that speeding will become even more prevalent, thereby exacerbating the risks noted above.

We therefore join in petitioning the City to install reasonably-spaced "speed bumps" and any other appropriate controls to help prevent speeding.
