Joe Dunstan is a landscape architect and educator with 36 years of experience in Landscape Architecture, park and recreation design, commercial site planning, accessible/universal design, and university teaching. For 24 years he was a landscape architect for the National Park Service where he was responsible for the planning, design and construction of visitor/recreation facilities, employee housing and maintenance facilities in 54 national parks and historic sites in six western states. During this time he completed numerous park master plans preserving ecological systems and enhancing historic landscapes, historic farms, and culturally sensitive landscapes.

Prior to NPS he worked in private practice for 10 years where he specialized in multi-family and commercial site planning and construction documentation. During the 1980's and early 90's he taught Landscape Architecture and site planning at the University of Washington, Seattle. Since retiring in 2012 he has taught site planning and urban design at California Polytechnic State University, San Luis Obispo, California on a part-time basis.

From 1995 to 2000 he was on the Board of Directors for Environmental Works, a non-profit community design center in Seattle that included six architects and a staff of nine. From 2004 to 2013 he was a member of the US Coast Guard Auxiliary on Bainbridge Island. He is currently a member of the woodworking steering committee for BARN (Bainbridge Artisans Resource Network) and is past commodore of the Eagle Harbor Yacht Club. He has lived on Bainbridge Island since 1995.
