

REGULAR CITY COUNCIL BUSINESS MEETING TUESDAY, MARCH 28, 2017

MEETING MINUTES

1. CALL TO ORDER/ROLL CALL/PLEDGE OF ALLEGIANCE - 7:00 PM

Mayor Tollefson called the meeting to order at 7:00 PM in Council Chambers.

Mayor Tollefson, Deputy Mayor Peltier and Councilmembers Blossom, Medina, Roth, Scott, and Townsend were present. Everyone stood for the Pledge of Allegiance.

AGENDA APPROVAL OR MODIFICATION/CONFLICT OF INTEREST DISCLOSURE

Mayor Tollefson proposed switching the order of items 6(A) and 6(B). Councilmember Scott moved and Deputy Mayor Peltier seconded to accept the agenda as modified. The motion carried unanimously, 7-0. There were no conflicts of interest disclosed.
